- 1. Finance Department Wendy Kinn. Items discussed and actions taken during the Finance Department report were as follows:
  - a) Provided the Financial Report for the Cooperative which included the September KWH sales use and revenue (revenue is ahead of budget by \$364,204.00), financial ratios, preliminary September, Form 7, year-to-date statistics, and the quarterly budget to actual variances.
  - b) 2018 capital credit retirement Following policy, the Cooperative retirement would be \$369,680.29 plus there is \$127,543.74 of G & T retirement for 2018. A motion was made by Presser, seconded by Klain, to retire Cooperative capital credits in the amount of \$369,680.29. The motion carried.

A motion was made by Behles, seconded by Odermann, to retire the G & T capital credits paid to the Cooperative in 2018 in the amount of \$127,360.57. The motion carried.
